7. Bids must be duly received by the BAC Secretariat at the address below on or before **12:00 noon, March 23, 2023**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids opening shall be on **March 23, 2023, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City**. Bids will be opened in the presence of the bidders representatives who choose to attend the activity.
9. Bidders/Contractors which have unfinished projects with the City Government beyond the target date of completion shall be Automatically Disqualified.

The **City Government of Surigao** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
