

Invitation to Bid

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The City Government of Surigao now invites bids for the above Procurement of Projects. Completion of Works is required 270 calendar days. - Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- A complete set of Bidding Documents may be acquired by interested Bidders on March 1, 2024 March 7, 2024, Mondays to Fridays from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, for the following:
- The City Government of Surigao will hold a Pre-Bid Conference on February 27, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City Which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before 12:00 noon, March 8, 2024. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bids opening shall be on March 8, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City. Bids will be opened in the presence of the bidders representatives who choose to attend the activity.
- Bidders/Contractors which have unfinished projects with the City Government beyond the target date of completion shall be Automatically Disqualified.
