Invitation to Bid

1. The City Government of Surigao through the *Bids and Awards Committee* invites contractors to submit bids for the following contracts:

ITB No. 2024-Infra-037

Contract Name: Reconstruction of Multi-Purpose Building

Contract Location: Brgy. Lisondra, Surigao City

Approved Budget for the Contract (ABC): 6,500,000.00

Contract Duration: 120 CD

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Surigao now invites bids for the above Procurement of Projects. Completion of Works is required 120 calendar days. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested Bidders may obtain further information from Bids and Awards Committee, thru the *BAC Secretariat Office, City Hall Compound, Surigao City* and inspect the Bidding Documents at the address given below from *9:00 A.M. to 5:00 p.m., Mondays to Fridays*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *May 28, 2024 – May 31, 2024, Mondays to Fridays* from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, for the following:
6. The City Government of Surigao will hold a Pre-Bid Conference on *May 24, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City* Which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *12:00 noon, June 7, 2024*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bids opening shall be on *June 7, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City*. Bids will be opened in the presence of the bidders representatives who choose to attend the activity.
9. Bidders/Contractors which have unfinished projects with the City Government beyond the target date of completion shall be Automatically Disqualified.
10. The *City Government of Surigao* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
