- The City Government of Surigao will hold a Pre-Bid Conference on April 3, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City Which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before 12:00 noon. April 17, 2024. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bids opening shall be on April 17, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City. Bids will be opened in the presence of the bidders representatives who choose to attend the
- Bidders/Contractors which have unfinished projects with the City Government beyond the target date of completion shall be Automatically Disqualified.
