

Invitation to Bid

- Bids opening shall be on September 17, 2024, 2:00 p.m. at CMO Conference Room, City Hall Compound, Surigao City. Bids will be opened in the presence of the bidders representatives who choose
- Bidders/Contractors which have unfinished projects with the City Government beyond the target date of completion shall be Automatically Disqualified
